



COMPETITION TERMS AND CONDITION

1. Promoter

4. SUBJECT OF THE COMPETITION

5. The prize is as follows:

1) The winner of the Competition, the author of the selected art work, will be awarded a material prize in the form of a FUJI INSTAX MINI

2) Prizes in the form of books and company gadgets will be awarded to the winners of the second and third place

3). The prize is as stated and no cash or other alternatives will be offered.

5. Terms

Art work should refer to the topic "Winter seen through the eyes of a child. The application should contain at least the following data: name of the participant, age, telephone number / email adres , short description of the art work.

2) Sending the application with a photo or bring it directly to the facility referred to in point 1) The winner agrees to the use of his/her name and image in any publicity material, as well as their entry.

3) From 5.12.2019r. till 31.12.2019r. on KIDS&Co.facebook page (run by Centrum Rozwoju Dziecka sp. z o.o.), leave your votes for your favourite photo using „Like it ”button.

4) The winner of the competition will be the person whose art work receives the most votes marked "Like" by 31.12.2020r. till 8 p.m

5) Votes can be cast by everyone who has an account on the Facebook site Photos and information about the event can be shared on other Facebook profiles.

6. Announcement of results

1) The results of the competition will be announced on January 11, 2020. At 11 a.m during the Open Day and on our KiDS&Co Facebook page. (run by Centrum Rozwoju Dziecka sp. z o.o)

2) In order to forward the prize, we will contact the winner of the competition regarding possible shipping data.

3) The winner of the prize agrees to provide address for shipping, otherwise it is tantamount to refusing to accept the prize. The data will be collected only for organizational purposes.

2) The organizer will send the awarded prize by post, courier or own suppliers within three business days from the day of announcement of the results of the competition.

7 COMPLAINTS

2) Complaints submitted after the deadline specified in paragraph 1 will not be considered.
