CONTEST RULES

1. ORGANIZER

- 2) The Winner shall not have the right to exchange the prize awarded in the Competition for its cash equivalent or for other material prizes.

7. ANNOUNCEMENT OF RESULTS

- 2) In order to distribute the prize, we will contact the winners of the contest regarding possible shipping details.
- 3) The winner of the prize agrees to provide the address data for dispatch, otherwise it is tantamount to a refusal to accept the prize. The data will be collected only for organizational purposes.
- 4) Within fourteen working days from the date of announcing the results of the Competition, the Organizer will send the prizes via **COURIER**.
- 5) The Organiser shall not be liable for any irregularities related to the operation of courier service providers and for any irregularities, including loss or destruction of the prize, during transport for reasons beyond the control of the Organiser.

8. COMPLAINTS

- 2) Complaints submitted after the deadline specified in paragraph 1 will not be considered.

9. FINAL PROVISIONS
