

Terms and Conditions of the Special Offer “PLN 0 Enrolment Fee + 2 Weeks of Free Settling-in”

§1 Promotion Organiser

The organiser of the “PLN 0 Enrolment Fee + 2 Weeks of Free Settling-in” promotion (hereinafter: the “Promotion”) is Centrum Rozwoju Dziecka Sp. z o.o., with its registered office in Warsaw, 00-867, ul. Chłodna 51, entered in the Register of Entrepreneurs of the National Court Register by the District Court for the Capital City of Warsaw, 12th Commercial Division of the National Court Register, under KRS No. 393956, with a share capital of PLN 104,750, NIP (Tax Identification Number) 525 251 54 91, REGON 142984383 (the “Organiser”).

§ 2. Place of the Promotion

The Promotion is conducted within the territory of the Republic of Poland at the Organiser’s facilities operating a network of preschools and nurseries under the KIDS&Co. brand, available via the website www.kids-co.pl.

§ 3. Promotion Period

1. The Promotion is conducted from 13 August 2026 to 30 September 2026 inclusive, which means that the childcare and educational services agreement concluded with the Participant must become effective no later than 30 September 2026, and at least one of the Participant’s children must begin attending an Organiser’s facility operating under the KIDS&Co. brand, in a preschool or nursery group, no later than that date.
2. The Organiser reserves the right to change the duration of the Promotion and shall not be held liable in this respect.
3. The Organiser shall not be held liable if the Participant is unable to take part in the Promotion within the period specified in section 1 for reasons beyond the Organiser’s control.

§4. Conditions of Participation

1. Only persons who jointly fulfil all the conditions set out in these Terms and Conditions may participate in the Promotion.
2. A Participant in the Promotion may be a natural person who jointly:
 - a) has full legal capacity and is at least 18 years of age;
 - b) is the parent or legal guardian of a child (or children) of nursery or preschool age, has enrolled the child in a KIDS&Co. facility, in a nursery or preschool group, and has signed an agreement for the provision of childcare and educational services during the Promotion period;
 - c) has never previously entered into an agreement with the Organiser for the provision of childcare and educational services;

d) is an individual customer, i.e. purchases the service for their own private purposes, unrelated to any business activity conducted by them.

3. Employees and associates of the Organiser may not participate in the Promotion.

§5. Promotion Rules

1. A customer who meets the requirements applicable to a Participant in the Promotion shall be entitled, under the Promotion, to the following:
 - a) the recruitment fee (also referred to as the enrolment fee) shall be PLN 0;
 - b) the child shall receive 2 weeks of free settling-in.

§ 6. Complaints

1. Complaints regarding the Promotion may be submitted during the Promotion and for 21 days following its end in the following manner:
 - 1) in writing to the Organiser's correspondence address, or
 - 2) electronically to: biuro@kids-co.pl
2. A complaint should include the Participant's full name, as well as a detailed description of and reasons for submitting the complaint.
3. The Organiser shall notify the Participant of the outcome of the complaint by registered letter sent to the address provided in the complaint or by e-mail (depending on the method used to submit the complaint) within 30 days of receiving the complaint.
4. Any disputes arising from participation in the Promotion shall be resolved amicably. If an agreement cannot be reached, disputes shall be resolved by a court of general jurisdiction competent for the Participant's place of residence.
5. The provisions of this section shall not exclude any rights granted to Participants under separate provisions of law.

§ 7. Personal Data

1. The controller of the Participants' personal data (hereinafter: the "Controller"), within the meaning of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation, hereinafter: the "GDPR"), is the Organiser.
2. The Controller may be contacted, including for the purpose of exercising data subject rights, via e-mail at: ochronadanychosobowych@kids-co.pl
3. Participants' personal data are processed for the purpose and to the extent necessary to conduct the Promotion, on the basis that processing is necessary for compliance

with a legal obligation to which the Controller is subject, in connection with the public promise referred to in Article 919 et seq. of the Polish Civil Code, pursuant to Article 6(1)(c) of the GDPR.

4. Furthermore, Participants' personal data are processed pursuant to Article 6(1)(f) of the GDPR for the purpose of pursuing, establishing or defending against potential claims – the Controller's legitimate interest consists in protecting its interests and legal rights.
5. Providing personal data is voluntary but necessary for the purposes specified above, including for the purpose of conducting the Promotion.
6. Personal data may be disclosed to entities authorised to receive such data under applicable laws.
7. The Controller may, under a written agreement, entrust the processing of personal data to third parties solely for a purpose and to the extent specified by the Controller and necessary to conduct the Promotion.
8. Personal data shall not be transferred to a third country or an international organisation.
9. Personal data shall be stored for the period necessary to fulfil the purposes for which they are processed, including for the purpose of conducting the Promotion.
10. Personal data shall be stored until the expiry of the applicable limitation periods, in accordance with generally applicable laws, for any claims that may be brought against the Controller.
11. The Participant has the right to access their personal data and the right to rectification, erasure, restriction of processing, data portability and objection to processing.
12. The Participant has the right to lodge a complaint with the President of the Personal Data Protection Office if they believe that the Controller's processing of personal data infringes the provisions of the GDPR.

§8. Final Provisions

1. The Promotion cannot be combined with any other special offers, discounts or reductions offered by the Organiser.
2. Matters not regulated by these Terms and Conditions shall be governed by Polish law.
3. The Organiser reserves the right to amend these Terms and Conditions in justified cases, in particular in the event of changes to the scope of services, the introduction of new services, or changes to pricing, commercial or marketing policies. Information about such changes shall be published on the website www.kids-co.pl and communicated by e-mail.

4. By participating in the Promotion, the Participant confirms that they have read and accept these Terms and Conditions.
5. Any disputed matters concerning the Promotion shall be resolved by the Organiser.
6. These Terms and Conditions shall enter into force on 13 August 2026.
