

Promotion Terms and Conditions “PLN 300 off per month for one year”

§ 1. Promotion Organiser

The organiser of the “PLN 300 off per month for one year” promotion (hereinafter referred to as the “Promotion”) is Centrum Rozwoju Dziecka Sp. z o.o., with its registered office in Warsaw, 00-867 Warsaw, ul. Chłodna 51, entered in the Register of Entrepreneurs of the National Court Register maintained by the District Court for the Capital City of Warsaw, 12th Commercial Division of the National Court Register, under KRS No. 393956, with a share capital of PLN 104,750, NIP 525 251 54 91, REGON 142984383 (hereinafter referred to as the “Organiser”).

§ 2. Place of the Promotion

The Promotion is conducted at the Organiser’s facilities operating under the KIDS&Co. brand and located in the following cities: **Wrocław, Katowice and Gdańsk**.

§ 3. Promotion Period

1. The Promotion runs from 11 September 2026 until 30 September 2026 inclusive. In order to participate in the Promotion, the Participant must sign an agreement for childcare and educational services during this period.
2. The agreement for childcare and educational services concluded under the Promotion must become effective no later than 31 January 2027.
3. The Organiser reserves the right to change the duration of the Promotion and shall not be liable in this respect.
4. The Organiser shall not be liable if the Participant is unable to take part in the Promotion within the period specified in section 1 for reasons beyond the Organiser’s control.

§ 4. Conditions of Participation

1. Only persons who jointly meet all the conditions set out in these Terms and Conditions may participate in the Promotion.
2. A Participant in the Promotion may be a natural person who jointly:
 - a) has full legal capacity and is at least 18 years of age;
 - b) is the parent or legal guardian of a child (or children), has enrolled the child in a KIDS&Co. facility, in a preschool or nursery group, and has signed an agreement for childcare and educational services during the Promotion period;
 - c) has never previously entered into an agreement for childcare and educational services with the Organiser;

d) is an individual customer, i.e. purchases the service for their own private purposes unrelated to any business activity conducted by them.

3. Employees and associates of the Organiser may not participate in the Promotion.

§ 5. Promotion Rules

1. A Participant who meets all the conditions specified in these Terms and Conditions shall receive a PLN 300 monthly discount on tuition fees for the first 12 months of the child's care and education at a KIDS&Co. facility covered by the Promotion.
2. The Promotion does not apply to meal fees.

§ 6. Complaints

1. Complaints concerning the Promotion may be submitted during the Promotion period and for 21 days after its end, in the following manner:
 1. in writing to the Organiser's correspondence address; or
 2. by e-mail to: biuro@kids-co.pl
2. A complaint should include the Participant's full name as well as a detailed description of and reasons for the complaint.
3. The Organiser shall notify the Participant of the manner in which the complaint has been considered by registered letter sent to the address provided in the complaint or by e-mail (depending on the form in which the complaint was submitted), within 30 days of receipt of the complaint.
4. Any disputes arising from participation in the Promotion shall first be resolved amicably. If no agreement can be reached, disputes shall be resolved by the competent common court having jurisdiction over the Participant's place of residence.
5. The provisions of this section do not exclude any rights granted to Participants under separate provisions of applicable law.

§ 7. Personal Data

1. The controller of the Participants' personal data (hereinafter referred to as the "Controller"), within the meaning of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation, hereinafter referred to as the "GDPR"), is the Organiser.
2. The Controller may be contacted, including for the purpose of exercising data subject rights, via e-mail at: ochronadanychosobowych@kids-co.pl

3. Participants' personal data are processed for the purpose and to the extent necessary to conduct the Promotion, on the basis of the necessity to comply with a legal obligation incumbent on the Controller in connection with the making of a public promise referred to in Article 919 et seq. of the Polish Civil Code, pursuant to Article 6(1)(c) of the GDPR.
4. In addition, Participants' personal data are processed pursuant to Article 6(1)(f) of the GDPR for the purpose of establishing, pursuing or defending possible claims. The Controller's legitimate interest consists in protecting its interests and ensuring legal protection.
5. Providing personal data is voluntary but necessary for the purposes specified above, including for participation in and implementation of the Promotion.
6. Personal data may be disclosed to entities authorised to receive such data under applicable law.
7. The Controller may, under a written agreement, entrust the processing of personal data to third parties solely for the purposes and to the extent necessary to conduct the Promotion.
8. Personal data will not be transferred to a third country or an international organisation.
9. Personal data will be stored for the period necessary to fulfil the purposes for which they are processed, including for the purpose of conducting the Promotion.
10. Personal data will be stored until the expiry of the limitation period applicable under generally binding provisions of law in respect of any claims that may be brought against the Controller.
11. The Participant has the right to access their personal data and the right to rectification, erasure, restriction of processing, data portability and objection.
12. The Participant has the right to lodge a complaint with the President of the Personal Data Protection Office if they believe that the processing of their personal data by the Controller infringes the provisions of the GDPR.

§ 8. Final Provisions

1. The "PLN 300 off per month for one year" Promotion may be combined with the special offer "PLN 0 enrolment fee + 2 weeks of free adaptation", addressed to parents or legal guardians who enrol their child in a KIDS&Co. nursery or preschool by 30 September 2026.
2. In matters not regulated by these Terms and Conditions, the provisions of Polish law shall apply.
3. Withdrawal from the services before the end of the first month shall not result in a refund of fees already paid.

4. The Organiser reserves the right to amend these Terms and Conditions in justified cases, in particular in the event of changes to the scope of services, the introduction of new services, or changes to pricing, commercial or marketing policies. Participants shall be informed of such changes on the website www.kids-co.pl and by e-mail.
5. By participating in the Promotion, the Participant confirms that they have read these Terms and Conditions and accept them.
6. Any disputed matters concerning the Promotion shall be resolved by the Organiser.
7. These Terms and Conditions are effective from 11 September 2026.
